- 2.2. The trustees shall have full power to compromise or compound all actions / suits and proceedings and all differences and demands, to refer any disputes or differences in the arbitration and to adjust, settle and approve all accounts relating to the trust fund.
- 2.3. The trustees shall purchase or acquire both agricultural and non-Agriculture properties & movable or immovable properties necessary for carrying out the objects of the Trust. Provided that no immovable property, belonging to the trust shall be sold, mortgaged, or leased unless decided by a resolution of the board carried by a majority of not less than two third of the number of trustees on roll. If a member fails to attend the meeting, he may give written opinion. A notice of not less than 15 days shall be given to all trustees before such a meeting is held.
- 2.4. To open accounts in Scheduled banks in the name of the trust and to operate such accounts by the President and Treasurer jointly.
- 2.5. The trustees shall generally purchase, take on lease or license or exchange, hire or otherwise acquire any real personal property or any interest therein, and any right, easements, privileges which the trust may think necessary or convenient with reference to any of the objects of the trust.
- 2.6. The trustee shall use the funds of the trust in the modes specified under the provisions of section 18(1)(d) r/w section 11(5) of the Act as mentioned from time to time.
- 2.7. The trustees shall ensure that the funds and incomes of the trust be utilized for the achievement of its objects and no portion of it shall be utilized for payment to the trustees, members by way of profit, interest, dividends etc.
- 2.8. The trustees can raise money by way of loans / borrowing from any banks or Financial Institutions necessary for carrying out its objective.

- 2.9. To receive gifts, donations, contributions, grants, subsidy and loans in cash or kind from individuals, funding agencies, philanthropic organizations and governments.
- 2.10. To accept donations, grants, presentations from local bodies, Institutions, Societies by Grant in aid & financial assistance from governments / organizations within and outside India for achieving objects of the Trust. In respect of the overseas funds the Home Ministry will be informed.
- 2.11. For the purpose of carrying out the objects of the trust the trustees shall be entitled to recruit & retain professionals, skilled personnel, technical advisors and engage such staff and servants and pay for their services such as fees, honorarium, salaries or remuneration and to relieve & terminate unproductive staff as and when required.
- 2.12. The trustees have right to get honorarium if the trust utilizes his/her services for any specific work for fulfilling any of the objects of the Trust as shall be decided by the trustees from time to time.

- 3.2. Further the settler of the trust hereby appoints Mr. Niranjana Sheelavant, Trustee of the second part as the permanent President of the Trust.
- 3.3. The minimum number of Trustees shall be 2 (three) & the maximum shall be 7 (Seven)
- 3.4. The president of the trust shall recommend the board of trustees to relieve/terminate any trustee whose activities are found to be against the aims & objectives of the trust or if they obstruct in smooth administration of the trust.
- 3.5. The President shall cancel any decision of the trustees if he deems that such a decision will affect the trust or damage to the trust.
- 3.6. A trustee shall cease to be a trustee if he is adjudged as insolvent or if he is convicted and sentenced to imprisonment for an offence and involving moral turpitude.
- 3.7. The board of trustees has got the power to co-opt trustees, which should not exceed more than five members including the permanent and existing trustees.
- 3.8. The board of trustees shall have powers to appoint sub-committees and governing councils, even consisting of persons other than trustees.
- 3.9. If a vacancy occurs in the Board of Trustees on account of death, resignation, removal or any other ground the vacancy shall be filled up by the president in consultant with other trustees.



**MEETING OF THE BOARD OF TRUSTEES:**

- 4.1. The board of trustees shall meet at least once in six months.
- 4.2. All decisions of the Board of trustees shall be by a majority of not less than two third of the number of trustees present at the meeting and shall be necessary for passing the following categories and resolutions:
  - 4.2.1. A Resolution to amend the terms of the deed of trust
  - 4.2.2. A resolution to remove / replace a temporary trustee
  - 4.2.3. A Resolution to sell or mortgage any immovable property of the trust or to lease any immovable property of the trust for a period exceeding 5 years.
  - 4.2.4. A Resolution to wind up the trust, and
- 4.3. The decision of the President shall be final except in clause A to D shown above.

5. **MANAGEMENT:** The management of the trust and its properties shall vest in the board of trustees.

8. Further no amendments shall be carried out without the prior approval of the commissioner of Income Tax.

10. It is hereby agreed and declared that the trust is an irrevocable trust in or under which the settler have no right in or title or interest or control or the claim.

11. It is hereby agreed and declared that the settler has hereinafter no right to change the trustee or appointed any new or additional trustees.
